- All vendors must be licensed with the Department of Revenue.

Indemnification and Agreement:

The Vendor agrees to accept full responsibility for the quality of any and all goods sold by the vendor and/or the vendors organization at the Pacific Northwest Mushroom Festival. Vendor agrees to be open for business during the Festival hours both days.

Late set-up or early tear-down, constitutes a breach of this agreement

Vendor agrees to include a Certificate of Insurance for public liability coverage of not less than \$1,000,000 per occurrence for bodily injury and property damage liability.
